**TREOIRLÍNTE MAIDIR LE SCÉIM DEONTAIS NA GAEILGE**

1. Ní chuirfear cúnaimh ar fáil ach amháin maidir le taispeántas nó imeacht eile a spreagfadh, i dtuairim na Comhairle, spéis phoiblí sa Ghaeilge agus a chuirfeadh eolas, tairbhe agus cleachtadh na Gaeilge chun cinn nó a chuirfeadh feabhas ar chaighdeán na Gaeilge.
2. Ba cheart iarratais maidir le tograí ealaíon traidisiúnta a chur chuig Scéim Cúnaimh faoin Acht Ealaíon.
3. Ní chuirfear cúnaimh ar fáil ach amháin do thaispeántas nó imeacht eile a thionólfar i gCo. an Chláir, nó atá baint ar leith acu le Co. an Chláir.
4. Caithfidh an t-eagarthóir nó an eagraíocht a bheith lonnaithe i gCo. an Chláir.
5. Ní dhéanfar taispeántas nó imeacht eile, a fhaigheann cúnaimh, a reachtáil ach i bhfoirgneamh nach mbaineann, i dtuairim na Comhairle, aon bhaol sábháilteachta leis.
6. Tabharfar deontas airgid mar chúnamh nuair a chuirfear cruthú caiteachais ar fáil.
7. Is €1000 an t-uasmhéid deontais maidir le taispeántas nó aon imeacht eile.
8. Is maidir le gníomhaíochtaí ar leith agus ní i dtreo íocaíocht fiacha, atá ann cheana féin, a dhéanfar deontas a bhronnadh.
9. Coiméadann an Chomhairle a ceart bronnadh deontais a dhiúltú gan aon chúis a thabhairt.
10. Níor cheart glacadh gur léiriú í íocaíocht deontais go ndéanfar a leithéid de dheontas nó aon deontas a íoc le heagarthóir nó eagraíocht maidir le himeachtaí sa todhcháí.
11. Ní bheidh iarratas ar Scéim Deontais na Gaeilge bailí ach amháin ar fhoirm iarratais oifigiúil.  
Ba cheart go mbeadh na sonraí seo a leanas san áireamh le hiarratas:-
  - (a) Ráiteas cuntas suas chun dáta, más ann dó
  - (b) Cur síos ar an taispeántas nó imeacht atá beartaithe
  - (c) Cur síos faoin gcaoi a chaithfear an t-airgead seo má éiríonn leis an iarratas seo
  - (d) Meastachán caiteachais agus ioncain maidir leis an togra
  - (e) Ráiteas maidir le deontais nó cúnaimh eile a fuarthas nó a lorgaíodh ó aon fhoinsé eile.
12. Chomh maith leis an eolas thuasluaite, ba cheart sonraí nó eolas breise a éilíonn an Chomhairle a bheith riachtanach chun iarratas a mheas a bheith curtha faoi iamh le hiarratais.
13. Ba cheart iarratais ar chúnamh a chur chuig: Oifigeach Forbartha Gaeilge, Comhairle Contae an Chláir, 1 Cúirt Bindon, Inis, Co. an Chláir.
14. Is é an spriocdátá ná an 27ú Meán Fomhair, 2007 ag 4.00i.n. Fogrófar Scéim eile ag tús mí Eanáir agus bainfidh an Scéim seo le himeachtaí a bheidh ag tarlú idir an chéad lá d'Eanáir agus an 31 Nollaig, 2008.
15. Is féidir leis an gComhairle athbhreithniú a dhéanamh ar na treoirlínite seo, ag aon am, ach ní bheidh na hathbhreithnithe seo chun dochair d'iarratais a fhaightear roimh na hathbhreithnithe seo.
16. Tuigtear má éiríonn le hiarratas go dtabharfaidh an t-eagarthóir nó an eagraíocht creidiúint do Chomhairle Contae an Chláir ar gach foilseachán agus/ nó agallaimh sna meáin. **TABHAIR FAOI DEARA: D'fhéadfaí, má theiptear creidiúint a thabhairt do Chomhairle Contae an Chláir, dochar a dhéanamh d'iarratais sa todhcháí.**

**GUIDELINES FOR THE IRISH LANGAUGE GRANT SCHEME**

1. Assistance shall be given only in respect of an exhibition or other event which when held would, in the opinion of the Council, stimulate public interest in the Irish language, provide a knowledge, appreciation and practice of the Irish language or improve the standard of the Irish language.
2. Applications for traditional arts projects should be made to the Assistance under the Arts Act Scheme.
3. Assistance shall be given only in respect of an exhibition or other event held in County Clare, or having significance to Clare.
4. The organiser or organisation must be Clare based.
5. An exhibition or other event in respect of which assistance is given shall be held only in a premises which, in the opinion of the Council, does not constitute a safety risk.
6. Assistance shall be by way of a money grant, on receipt of proof of expenditure.
7. The maximum grant in respect of any exhibition or other event shall be €1000
8. Payment of a grant will be in respect of specific activities and not towards the payment of former debts.
9. The Council reserves the right to refuse to make a grant without giving any reason.
10. The payment of a grant is not to be taken as an indication that an equal or any grant will be made to the organiser or organisation in respect of further events.
11. Application for the Irish Language Grant Scheme will only be valid on an official application form. Applications should include the following particulars:-
  - (a) An up to date statement of accounts if available
  - (b) A description of the proposed exhibition or event
  - (c) A description of how this money will be spent if this application is successful
  - (d) An estimate of the expenditure and income in respect of the project
  - (e) A declaration of grants or other assistance received or sought from any other source.
12. Apart from the foregoing, applications shall furnish such further particulars or information as the Council may deem necessary to consider the application.
13. Applications for assistance should be addressed to: Oifigeach Forbartha Gaeilge, Comhairle Contae an Chláir, 1 Cúirt Bindon, Inis, Co. an Chláir.
14. The closing date shall be on **September 27<sup>th</sup>**, at 4.00 pm. Another Scheme will be advertised at the start of January for events taking place between January 1<sup>st</sup> and December 31<sup>st</sup>, 2008.
15. These guidelines may, at any time, be reviewed by the Council but such reviews shall not prejudice applications received before these reviews.
16. It is understood that if an application is successful that the organiser or organisation will credit Clare County Council on all publications and or media interviews. **PLEASE NOTE: Failure to credit Clare County Council may jeopardise future applications.**
